

MULE SHOW GENERAL RULES & DISCRIPTIONS

All classes will be conducted & judged in accordance to AMA rules.

Complete one entry form for each animal or team. Entry form must include AMA numbers for owners, exhibitors & animal. Please make additional copies for each entry.

Pre-Entries are due by 10 PM on Monday October 18th. Please make checks payable to: W&KRP. Post -Entries will be accepted with a penalty of \$2/class, including those exhibitors entering throughout the day of the show. Those individuals pre-entering & then not showing up the day of the show without notification will be charged a fee of \$25. Notification will include a phone call or a text only to 559/903-0707. Please, do not email or Facebook your notification.

Each mule is required to pay the CA drug fee (\$8) as defined by law (Section 1280.2)

Each person must have a current year's "Release of Liability" signed & dated before numbers will be issued. It is the rider's responsibility to be sure they are wearing the correct number. Not wearing your exhibitor number or the correct number in a class is an automatic DQ.

ALL Returned Checks will be assessed a \$30 penalty & must be replaced with a cashier's check, money order or cash including penalty, within 5 days of notification.

There will be NO re-deposits. If unpaid within the 5 days, we will turn offenders in the DA's office. A \$15 billing fee will be added to any unpaid balance.

Please stay out of the Main Barn unless you are renting a stall. Please adhere to our barn rules. There is <u>NO</u> use of hoof black or oil-based dressing on the alleyway!

PARKING is in the PARKING LOT: No Trailer/ Exhibitor Parking in the courtvard unless specifically assigned by management.

Please be at the gate ready to go when your number is called. There will be a 1 minute gate call. NO admittance once the gate is closed. Please advise staff of tack changes or any conflicts. We will do our best to accommodate all exhibitors. No shows without scratching in the office will be charged for the class.

Scratches <u>MUST</u> be made IN THE OFFICE at least 1 class prior to the running of your scheduled class & will be charged a \$2/class scratch fee. Add-ons may be done at the gate if you have an open check or send a representative to the office to pay. Open checks may not be closed until all class sheets have come to the office & entries have been verified. Please settled up before leaving the facility.

Please be aware that the warm-up arena is a multi-purpose arena with riders & mules & donkeys of various disciplines & skill levels all using it simultaneously. Riders, Trainers & owners are ultimately responsible for their own, their clients or family members & their mules & donkeys' safety. Neither Kathy R Pettit, W&KRP Equine Enterprises, its volunteers & staff nor Verde View Farm can assume any liability for what might occur when you choose to ride in that arena, before or during or after the mule show.

Jumper classes will be judged **Table 2**, **Section 2b**. Ties for 1st will have a second jump off, all others will be determined by a coin-toss.

In all Show Champion Award categories; ALL ties will be broken. AMA point system will be used to calculate awards. You must show in at least 6 classes (where applicable) to be eligible for a Show Champion Award. In Show Champion categories with fewer than 6 eligible classes, you must show in at least half plus one of the eligible classes to win the Show Champion award. Please NOTE: some of the Show Champion Divisions include Non-AMA approved classes & often determine winner when there is a tie

WESTERN NON-AMA CLASS DEFINITIONS: Most Colorful Mule At Halter is a halter class judged solely on the color & markings of the animals exhibited. Open Walk/Jog Western Pleasure is for all riders. Mules judged on way of going at the walk & jog both ways in the arena. No loping. May be asked to extend either gait. Open Walk/Jog Trail is for all riders. Mules & donkeys judged on way of going at the walk & jog over trail obstacles. Discipline Rail is a "Simon Says" formatted class that can include advanced gaits & maneuvers. Mulemanship is a pattern class judged on the riders ability to execute a prescribed pattern.

PACKING NON-AMA CLASS DEFINITIONS: Two Man Box Hitch is a class requiring two people as a team executing all the same requirements of the Box Hitch classes. Two Mule Hitch ~ One Box & One Diamond is a class requiring two mules as a team executing a Box Hitch on one mule & a Diamond Hitch on the other.

All children under the age of 10, NOT showing, <u>must</u> remain with & under the supervision of their parent(s). The Hot Walker is not a toy. Please keep ALL children away & off of it

For safety reasons, all dogs are to be kept on leashes at all times. If you have to bring your dog, PLEASE clean up after him or her.
